## **ESIF Annual Summary Report 2018**Staff Working Document on evaluations

- Increase in completed evaluations, but lower than planned in EP
- Few impact evaluations, often include process/monitoring
- Good clarity and suitability of evaluation design
- Better data quality and availability
- Findings and conclusions need strengthening

#### Completed:

- Major projects 2000-2013 in the transport sector (incl. Malaga new west bypass)
- European Solidarity Fund 2002-2016

#### On-going:

- Major projects 2000-2013 in the environment sector (incl. Águilas desalination plant)
- Jaspers (Joint Assistance to Support Projects in European Regions)


#### **Upcoming:**

- R&D infrastructures and activities ex post 2007-2013 (2019)
- e-Cohesion (2019-2020)
- ICT and Broadband ex post 2007-2013 (2019-2020)

## Support to MS on evaluation

- 1) Peer reviews (final evaluation reports or full dossiers, incl. ToR)
- 2) Training Summer schools (Terms of Reference, Theory-Based Evaluation, Counterfactual Impact Evaluation)
  - > 2019 edition will be announced soon
- 3) Methodological support (Latvia, Greece, Croatia, ...)



# **Post-2020 provisions Evaluation – what stays**

#### Member states (art. 39):

- Evaluations during the programming period
- Functional independence of evaluators
- MS to guarantee procedures necessary to produce and collect data needed for evaluations
- Evaluation plans to be submitted to MC within 1 year of programme adoption
- MCs to examine progress in evaluations, synthesis and follow-up to findings (art. 35)

Commission (art. 40): Impact evaluation of Funds (by 2031)



## Post-2020 provisions Evaluation – what changes

- MS evaluations to assess programme relevance, effectiveness, efficiency, coherence and EU added value
- Programme impact evaluation by June 2029
- MS to publish all evaluations on website
- Commission's mid-term evaluation by end 2024
- Ex-ante evaluation no longer obligatory
- No more reporting on synthesis of evaluations (only MC, no AIR)
